UK Carrier Scheme

The UK Carrier Scheme is an authorisation that enables businesses to move eligible consumer parcels, from Great Britain to Northern Ireland, in line with Windsor Framework arrangements.



Northern Ireland Retail **Movement Scheme**

Establishes a new way to move prepacked retail goods from GB into NI. Goods can move on the basis of a single General Certificate for eligible consignments, supported by a packing list. There will be no requirement for an official veterinarian or plant health inspector to approve the documentation.



Northern Ireland Plant **Health Label Scheme**

The NIPHL Scheme provides growers, farmers and other relevant traders in GB can move plant products and used agricultural & forestry machinery to NI. Traders can move these goods with a NIPHL and without a phytosanitary certificate.





UKIMS UK Internal Market Scheme

UKIMS is an authorisation that allows you to declare your goods 'not at risk' if they are brought into NI for sale or final use by end consumers in NI (and GB in the case of movements from GB) and meet all the other criteria to move under UKIMS as set out in the guidance.



SPIMM

simplified processes for **Internal Market Movements** Simplified custom movements available to Traders under the Windsor Framework where goods are moving from GB-NI via direct movement and are 'not at risk' of entering the EU.



IMMI

Internal Market Movement Information

Simplified data set of information submitted to TSS.



Jargon busting

Additional Procedure Codes - A three—digit code used to identify any supplementary conditions that apply to the intended use of the goods – required for Entry into Declarant Records

At Risk - Applies to goods that enter NI but may later be sold or consumed within the EU, goods moved into NI for commercial processing and any goods subject to EU trade defence measures

Categorisation - The process of categorisation looks at the product specific composition and origin of goods.

Commodity Code - A sequence of digits used to identify goods for customs purposes

Country of Origin Country of Origin is the economic nationality of the goods being imported and exported

EIDR An EIDR allows economic operators to release goods to a customs procedure using a simplified data set via an entry in their electronic commercial records

ENS - The entry summary declaration will have safety and security information about your goods and is submitted before your goods arrive at the border.



Jargon busting

EORI - This is an identification number for trade parties performing international movements under customs procedures

Free Circulation – Goods that have been cleared by Customs authorities following the payment of any customs duties attached to them, and their documentation has been approved

GMR - A Goods Movement Reference provides approval to move goods and is issued through the Goods Vehicle Movement Service

Goods Description - a description of the goods which is specific enough to allow the unambiguous identification, classification and examination of goods

Not At Risk - Applies to goods that will be for sale to or final use by end-consumers located in the UK and are moved into NI by a business authorised under the UK Internal Market Scheme (UKIMS)

SCDP - Simplified Customs Declaration Processes

TGP – Trader Goods Profile is a unique 'goods profile' that will enable Traders to pre-populate some of the information on an IMMI, instead of providing commodity codes to the TSS or an agent for each movement

UKIMS-EIDR – The UK Internal Market Scheme Entry in Declarants Records is an authorisation issued to an individual trader to enter details of movements under the SPIMM in their own records at the time of movement*



Having a UKIMS authorisation will allow you access to the simplified processes for Internal Market Movements for your 'not at risk' goods moving from GB to NI.

UKIMS RESOURCES

How to subscribe

You'll need the Government Gateway user ID and password that you use for:

- your business or organisation
- yourself, if you're applying as an individual

If you do not have a user ID, you can create one when you start.

You cannot use an agents Government Gateway user ID.

You'll need to tell HMRC:

- your EORI number that starts with GB or XI if you do not have one you can apply for an EORI number when you subscribe you'll need to meet the eligibility criteria to register for an XI number
- your Unique Taxpayer Reference (UTR) find your UTR
- the address for your business that they hold on their customs records
- your National Insurance number (if you're an individual or sole trader)
- the date you started your business

Your EORI number and Customs Declaration Service accounts will be linked to your Government Gateway user ID. You cannot apply for more than one EORI number using your Government Gateway user ID.

CHECKLIST FOR WINDSOR FRAMEWORK READINESS

How can you best prepare for the Windsor Framework?

INTERNAL MARKET READINESS

- Are you eligible to move your goods using Internal Market Movement Information (IMMI)?
- Have you registered for UKIMS if it is available?
- If you are registered for UKIMS, have you uploaded your UKIMS authorisation letter?
- If moving goods on your UKIMS authorisation, do you have the sufficient evidence to prove those goods are 'not at risk'?
- If your goods meet the NIRMS or NIPHL criteria, have you registered for the relevant scheme?

SUPPLY CHAIN READINESS

- Do you know who is moving your goods?
- For NI Receivers, have you had a discussion with your supplier and the haulier and Fast Parcel Operator, if required, about your requirements?
- For GB Suppliers, have you had a discussion with your NI Receiver, the haulier and Fast Parcel Operator, if required, about your requirements?
- Are you confident that you are using the correct EORI number?
- Are you using the correct or sufficient goods description for your movements?
